One full scholarship will be awarded per session, and is available for families who would otherwise be unable to pay the Camp tuition. Applicant families must be able to demonstrate financial need. All inquiries and financial information will be kept strictly confidential.

All Camp applications and tuition fee of \$295 are due no later than the close of business on Friday May 18th, 2012. Sessions fill fast, so please be sure to register early!
